## **\$10.00 non-refundable application fee required**

It is the goal of the Jacobs School of Music to extend financial aid to families who demonstrate a commitment to musical education for their children. However, financial aid resources are extremely limited. The fees of the Pre-College Programs are subsidized by Indiana University as a community outreach commitment.

Financial aid is awarded to families who have a total family income under \$35,000 per year for school year programs and \$50,000 per year for summer programs.
